Aloha, Joyce...

Ricardo from Hawaii sends you greetings across the miles. I pray this messages reaches you in good health and settled into your new Epoch Times Newspaper facility. Thank you for your continued interest in my story. Several texts I sent you recently and a request for a return phone call via voice mail remain unanswered. These incidents are identical to those involving illegal surveillance, phone intrusions, stalking, and other cyber crimes I've encountered over and over again. If you or anyone from the Epoch Times editorial staff has sent me emails or tried to call me since my visit there and did not receive a reply, or called and received everything except me speaking live, their call was blocked from connecting.

Cyber criminals block emails I send depending on the addressee. Calls I make to certain phone numbers are blocked. For instance, calls I've placed and emails I've sent to Mrs. Sharon Rondeau, the editor of the Post & Email online news source (<https://www.thepostemail.com> (203) 987-7948 and (860) 556-9392 been blocked for months. In 2018 Editor Rondeau wrote a story about my persecution. I've included her in this email.

We may find our interaction has been compromised. I called your number four times last week and just before sending this email. Each time I reached your voice mail. Each time I left a message asking for you to return my call. All times are Pacific Time:

Wednesday, 5/10/23: 3:54 p.m

Thursday, 5/11/23: 9:06 a.m. and 3:44 p.m.

Friday, 5/12/23: 12:32 p.m.

Monday, 5/15: 9:17 a.m

If you called my number and reached voice mail or a busy signal then my attackers blocked your call.

The cyber criminals break my Virtual Private Network software to ensure illegal surveillance and online stalking can continue. As a safeguard for your receipt of this message I also included as cc's your main inquiry email address (inquire@epochtimes.com), Mr. Cosgrove (chwinncosgrove@epochtimes.nyc) from the Epoch Times who identified and validated the evidence package I sent to your Santa Clara office in 2020 was intercepted and stolen by my attackers to prevent review, Mr. Worchester (nathanworchester@epochtimes.us) who has educated me many times through his privacy-related articles, and Mr. Truesdale, (jacksontruesdale@protonmail.com) a reporter from the Hawaii Civil Beat news source who is reviewing evidence I've presented him to support my cyber attack and whistle blowing retaliation claims.

Ladies and Gentlemen, please confirm you receive this message and attachment. Thank you.

Joyce, I attached a Memo for Record dated today that details communication-related incidents I've encountered since my personal visit with you a few weeks ago. I also have an updated cyber crime evidence website referenced in the memo: <https://bit.ly/3LEINLX> Please forward all information to your national desk.

Please advise if you or any other member of the Epoch Times has tried to reach me and failed. I have an encrypted email portal set up to communicate once we establish authentic connectivity. Please reply to me at nikon@precisionphotography.live. Please put brackets at the beginning and end of the subject line to encrypt the email. Example: [Reply to Ricardo Finney]. When you receive my reply please access the link you'll receive to open my email. Please reply to nikon@precisionphotography.live with the subject content enclosed in brackets.

When your busy schedule allows, please call me at 808 255-9701. Again, if you receive a busy signal or voicemail, the call is being blocked by my attackers. Please keep trying to reach me. I look forward to receiving your reply here and phone call. Thanks to everyone for your valuable time.
