

Memo For Record - 5/8/24

Online Identity Theft/Extortion Attempt

On 4/4/24 in Facebook Messenger I sent a request for help to who I thought was Attorney Alina Habba, former President Trump's lawyer. On 4/27/24 I read a reply. Initially I was unaware the response came from an impersonator/cyber criminal. I've detailed our interaction which includes an extortion attempt by the hacker. After securing a body of evidence I ended communication on 5/3/24.

The attached screenshots numbers 1-47 were captured during our Facebook Messenger sessions. The screenshots after #47 depict my cyber crime evidence website: <https://www.hiddenfederalwhistleblower.com> (Please note the embedded contact requests in yellow).

To their discredit, in addition to these crimes, cyber criminals (hackers) known and sanctioned by the weaponized multi-federal organization DC/State/City & County cabal have intercepted and blocked nearly 300 emails, texts, webpage contacts, faxes, and phone calls I, or those I've hired have attempted to send seeking media, legal, or political help.

Screenshot #1 and #2: My request for help sent to Attorney Alina Habba as depicted in FaceBook.

Screenshot #3: Response from who I would learn later was an imposter. My reply begins.

Screenshot #4 and 5: My reply continues.

Screenshot #6 and 7: Hackers advise about sent email.

Email from alinahabba01@gmail.com

An email I received purportedly from Attorney Habba went directly into quarantine after it was suspected to be infected with malware, a hijacked web address, etc. All my attempts to contact lawyers are blocked.

Screenshot #8 and 9: Email received from alinahabba01@gmail.com (Infected/placed into quarantine). My blocked email notice. I asked for a phone call while Alina Habba appeared active. I waited in Messenger, no reply. As expected, no call received.

Screenshots #10 thru #13: Hacker asked me to send my email address. I asked to resend email using business address. As expected, refused. I explained more about blocked email. Refused to hold voice or FaceTime call.

Screenshot #14: Refuses to send business email. Asks me to repeat needs.

Screenshot #15: Imposter asks for information already provided.

Screenshot #16 and #17: Recommends voice recording, introduces colleagues who can "help", needs payments

Screenshot #18: My query asking for payment method.

Screenshot #19: Imposter asks me to send direct messages.

Screenshots #20 thru #24: Impersonator states joined by two more civil rights attorneys and a reporter. Explains \$700 per hour rate and \$500 per hour per colleague. Needs \$1600.00 retainer. Banter about making sure "they" pay heavily. I acknowledge and stand by.

Screenshot #25 and #26: Impersonator details payment methods, all without a paper trail including cash mailing as an option. I chose a money order.

Screenshot #27: Impersonator provides this address to send my money order: Linda Marie Gerda, 1825 Clearwater Dr. SE, Marietta, GA 30067. Three days after I received the address it disappeared from the text string.

Screenshot #28 and #29: I advise I'm going offline for a few days and ask for a phone number to ensure connectivity.

Screenshot #30: Impersonator sends a phone number that only supports texting. Asks when am I making the payment. Three days after I received the (719) 695-9185 phone number it disappeared from our text string. Misspelled words start.

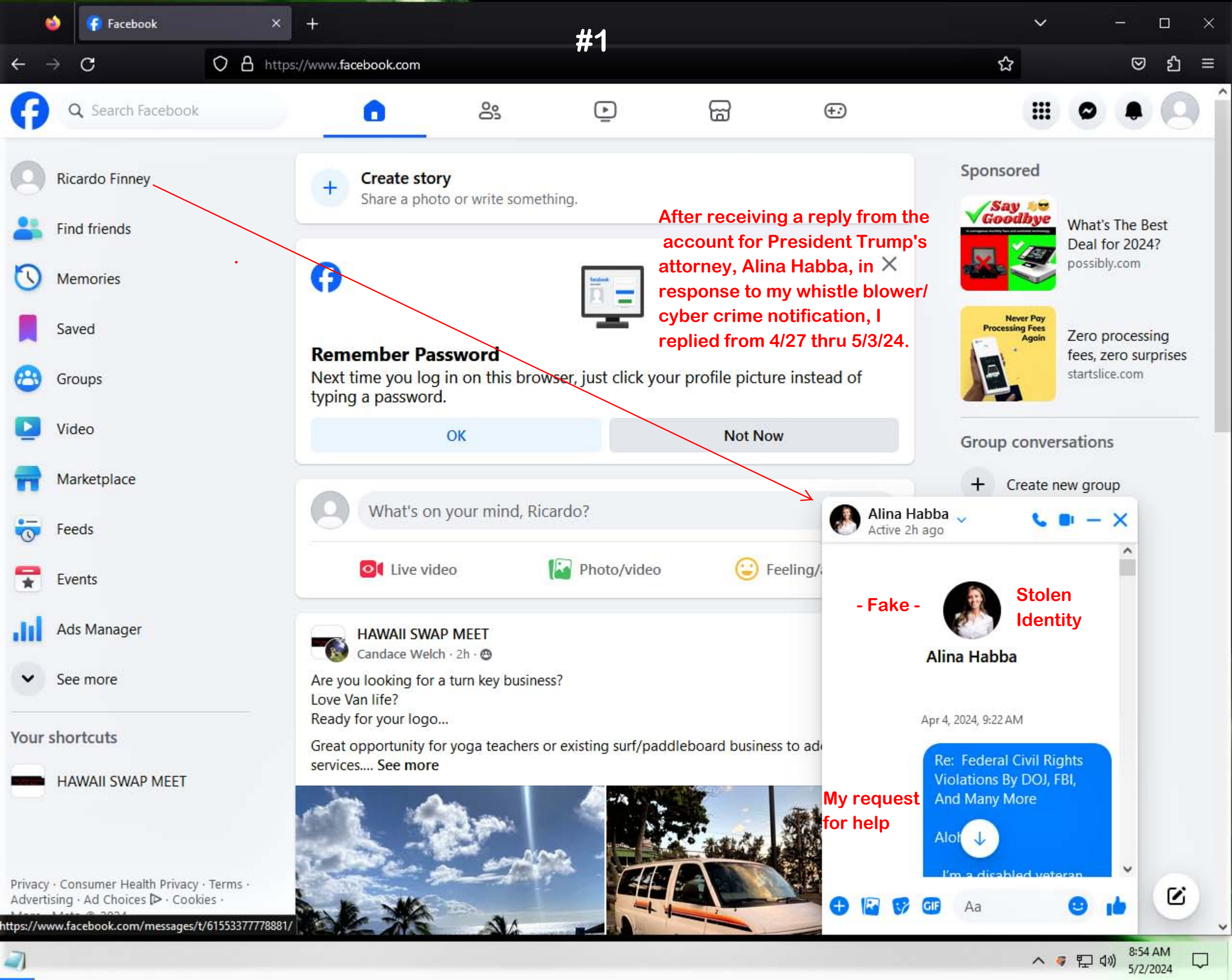
Screenshots #31 thru #37: Series of wordspeak promises rife with tricks, ploys, tactics, lies, and acts of omission identical to my dealings with Hawaii law enforcement and the rest of the cabal.

Screenshots #37 and #38: I ask for the 10-digit phone number for voice communication.

Screenshots #38 thru #47: A non-reply from a demonic hand.
