

Using my home business network, on August 8, 2024 I accessed the news website for civil rights attorney Leo Terrell at <https://www.leoterrell.com>. I posted a request for legal representation. I attached screen shots captured during my online session and a copy of the content I posted in the website's "Contact Me" portal.

A reply to my email addresses or my Veteran's Administration Advocate was not received. I surmise as has been the case over 350 times, cyber criminals blocked my communication attempt to keep all crimes hidden and unknown.

I surmise my communication attempt was blocked by the DOJ/FBI-sanctioned cyber criminals. My belief can be disproved or verified by contacting Attorney Terrell and asking if he received my submission or if so, replied to it. As has been the case with hundreds of other website posts, phone calls, emails, texts, and faxes I've sent that were intercepted and blocked, I am certain he did not receive my website entry.
