Cyber criminals known by the DOJ and FBI have "shadow banned" my TruthSocial username @Ricard0\_Finney136 and my X username @phillip\_aeros. Since establishing my X and TruthSocial accounts in November 2023, I have not received replies to dozens of direct and public postings revealing criminal acts. My X and TruthSocial usernames do not appear is web searches. This occurs because my comments and postings are visible to me but not other users on the social media platforms.

My X and TruthSocial useranames are also hidden from web searches.

To keep their nefarious deeds unknown, my attackers hide my online presence by shadow banning my crime evidence. Interaction with my content is deceptively hidden in X and TruthSocial. Evidence follows.






Shadow banning, also called stealth banning, hellbanning, ghost banning, and comment ghosting, is the practice of blocking or partially blocking a user or the user's content from some areas of an online community in such a way that the ban is not readily apparent to the user, regardless of whether the action is taken by an individual or an algorithm. For example, shadow-banned comments posted to a blog or media website would be visible to the sender, but not to other users accessing the site.

The phrase "shadow banning" has a colloquial history and has undergone some usage evolution. It originally applied to a deceptive sort of account suspension on web forums, where a person would appear to be able to post while actually having all of their content hidden from other users. More recently, the term has come to apply to alternative measures, particularly visibility measures like delisting and downranking.<sup>[1]</sup> This is the attacker's intent:

By partly concealing, or making a user's contributions invisible or less prominent to other members of the service, the hope may be that in the absence of reactions to their comments, the problematic or otherwise out-of-favour user will become bored or frustrated and leave the site, and that spammers and trolls will be discouraged<sup>[2]</sup> to continue their unwanted behavior or create new accounts.<sup>[3][4]</sup>








I refreshed the X page and found my uploads had disappeared. The cyber attack made through the unsecured link was successful. My posts were intercepted and blocked to prevent viewing and investigation.





My accounts in X are invisible in searches, at any given time I have 20-40 persons who follow my account to stalk activity. Nearly all joined X in the past 60 days. As fast as I block names new ones appear. None correspond and only observe my account activity.


