Although a delivery receipt was generated, none of the individuals received my email. Representative Garcia verified he did not receive my email.

This communication is one of nearly 400 emails, texts, faxes, and phone calls blocked by cyber criminals known and sanctioned by the DOJ/FBI/Politician-led cabal. They block all my messages attempting to keep their corruption hidden and silent.
