Re: Federal Civil Rights Violations by Government Agencies

Aloha,

My first and fourth US Constitution amendment rights have been severely violated by multiple city, state and federal government and law enforcement officials. My family and I have been subjected to illegal on and offline surveillance, online stalking, unauthorized cell phone wiretapping and call blocking, business network interference, and computer destruction. These federal civil rights violations are known and allowed by members of the Department of Justice, the Federal Bureau of Investigation, the Hawaii Field Office of the Federal Bureau of Investigation, the Hawaii Attorney General, the Mayor of Honolulu, the Honolulu Police Chief and several of his officers. All have been, and continue to conspire to violate my rights while participating in a wide-ranging, multi-agency federal whistle blower cover up.

The FBI violated my first amendment right of freedom of speech by allowing cyber attacks that damaged my computers and prevented me from freely operating my computer-based business, communicating with social media, cyber security firms, news sources and other informational, and open public forums that support freedom of speech. The FBI should not keep me from having freedom of speech. The FBI should not keep me from having freedom of the press to publish my situation. The FBI allows the cyber attacks to continue unchallenged..

The FBI violated my first amendment right to petition the government for redress of grievances by refusing to investigate 30 cyber crime complaints I submitted, all supported by forensic, audio, video, graphic art, and photographic evidence backed by expert witness testimony, and did so as part of a multi-agency federal whistle blower cover up.

The FBI should not ignore my 30 cyber crime complaints I've filed for more than seven years. I have a right to petition the government to fix problems, especially those that are criminal and affect my livelihood. The FBI has caused me great harm by purposely ignoring my 30 cyber crime petitions filed from August 2016 through September 2023 seeking relief from constant nation-state level cyber attacks.

The FBI violated my fourth amendment right to privacy by conducting or condoning illegal indoor and outdoor vehicle, computer device, and cell phone

surveillance against my family and I. The FBI should **not** have ignored my repeated very detailed cyber crime complaints. The reports include fervent appeals for federal law enforcement intervention based on the complexity and sophistication observed in each damaging nation-state level cyber attack..

The FBI's shameful actions are sanctioned by the DOJ who refused to respond to my request for intervention. The FBI has been allowing the cyber attacks against me to happen and knows who the cyber attackers are.

Violations by members of the Honolulu Police Department Criminal Investigations Division (HPD/CID) against me are especially egregious. Evidence I have posted online proves my claims are valid.

The HPD/CID violated my first amendment right of freedom of speech by **allowing** cyber attacks that damaged my computers and prevented me from freely operating my computer-based business, communicating with social media, cyber security firms, news sources and other informational, and open public forums that support freedom of speech. The HPD/CID should not keep me from having freedom of speech. The HPD/CID should not keep me from having freedom of the press to publish my situation by allowing the proven cyber attacks to continue unabated.

The HPD/CID violated my first amendment right to petition the government for redress of grievances by refusing to investigate 36 cyber crime complaints I submitted with all supported by forensic, audio, video, graphic art, and photographic evidence backed by expert witness testimony, and did so as part of a multi-agency federal whistle blower cover up.

The HPD/CID should not ignore my 30 cyber crime complaints. I have a right to petition the police arm of the government to fix problems, especially those that are criminal. The HPD/CID has caused me great harm by purposely ignoring my 36 cyber crime petitions filed from August 2016 through September 2023 seeking relief from constant nation-state level cyber attacks.

The HPD/CID I violated my fourth amendment right by condoning illegal indoor and outdoor vehicle, computer device, and cell phone surveillance against my family and I. The reports include fervent appeals for city law enforcement intervention based on the complexity and sophistication observed in each damaging cyber attack..

My evidence proves officers in the HPD/CID lied, committed well-designed acts of omission, twisted facts, and evaded answers for months and years to avoid conducting a thorough criminal investigation with findings and conclusions but instead allowed the cyber crimes to continue unchallenged. Under the guise of law enforcement intervention I asked for my constitutional rights as a lawful

citizen to be protected. HPD/CID ignored me at every request for protection.

The HPD/CID's shameful actions are sanctioned by the Mayor of Honolulu and his police chief, all documented in detail. The HPD/CID allowed the attacks to happen knowing the source and why they were allowed. The HPD/CID knows the attacks are condoned and supported by the FBI as they colluded with the FBI to not intervene as the attacks continued ignoring my repeated pleas for investigations. In response to my question asking if officers were directed to not investigate my cases, HPD/CID stated officers are trained to detect crimes in a fair and impartial manner and that they were never directed to not investigate any criminal activity by any supervisor or higher activity. The collusion with the FBI to not investigate my litany of local, US Mainland, and international cyber crime statements proves the HPD/CID claim is not true.

My evidence exposes the lie. Officers purposely did **not** investigate my cases, thus why HPD/CID cannot produce a single thoroughly investigated, completed case from the 36 cyber crime statements I filed. After ignoring my cases to avoid having to refer those involving US Mainland and Canadian witnesses to the FBI, HPD/CID rushed to permanently close them all without giving me due process, claiming I was "uncooperative". Two months later HPD/CID "reopened" my cases without my involvement, barred me from participating, then closed my cases again after applying a deceitful but successful tactic that **again** eliminated the testimony of one of my most important witnesses.

As previously noted, I made the HPD/CID misconduct known to the Hawaii State Attorney General, and the Mayor of Honolulu. Nothing changed.

My desire is to have a civil rights attorney present my evidence to a federal judge who can:

- mandate the cyber attacks against me be investigated and stopped.
- mandate law enforcement oversight to ensure I resume having uninterrupted, private communication with other citizens as the US Constitution entitles me to have.
- demand accountability for the federal violations of my first and fourth amendment rights from the parties noted in my opening paragraph.
