

Talk Show Host Dennis Prager - My Text Sessions With An Impersonator -

On April 5th 2024, I used my illegally wiretapped iPhone with the Facebook Messenger app to text the radio, talk show, and podcast host, Mr. Dennis Prager seeking media help. I find his candor and honesty in his broadcasts very refreshing and admire his excellent Pragertopia business model. I posted a description of the federal, state, and city retribution I receive and sent a request to investigate my whistleblower and cyber crime victim claims.

Initially encouraging, the responses I read from "Mr. Prager" throughout April 6th dwindled to zero, and did so in a most bizarre way. Based on how all went down, my text conversation with "Mr. Prager" wasn't really with the real Mr. Prager. I connected with the satanic hand of the attackers that illegally monitor and cyber attack my phone, computers, and tablets around the clock.

For simplicity I'll continue to address the illegal contact as "Mr. P". From big media promises made upfront, to confirming contacting Sen Jim Jordan, House Oversight Committee and RNC Co-Chair Lara Trump on my behalf and arranging for them to join in a live broadcast, the offers "Mr. P" made were huge and perfect for me. But it all turned odd quickly.

After asking for my X username, "Mr. P" refused to connect in X. "Mr. P" promised a live television broadcast, access to his personal lawyer, and promised front money for live broadcast fees then attempted extortion by demanding hundreds of dollars be sent via PayPal to a different name. "Mr. P" refused to connect FaceTime, voice via voice in his radio show.

I received replies, not from Mr. Prager but from online attackers who intercept and block or manipulate calls and texts sent to me, illegally monitor and block my cell phone calls, hack and disable my devices, and prevent my X username (phillip_aeros) and TruthSocial (Ricard0_Finney136) from being found in online searches. (Please search for both...You won't find either username in Google, taken down my cyber criminals trying to hide me and my crime evidence from view. My posts reveal the corruption)

The screenshots that follow reveal my interaction with the imposter. Cyber criminals continue to block my efforts to reach the real Mr. Prager. Reporting the intrusive cyber attack to law enforcement authorities in Hawaii is useless as I am victimized by collusion, lawfare, and corruption. I made my first cyber crime report to the FBI and Honolulu officials in August 2016. Since then they have purposely ignored over 300 crime reports, complaints, letters, and email requests for intervention I've filed.
