

To prevent their crimes from being exposed and demands for accountability arising, cyber criminals routinely block my attempts to get legal assistance from civil rights attorneys. Here is one of several examples of their illegal surveillance and computer intrusion. I have reported similar incidents to the FBI and Honolulu police who refuse to act because of collusion.

In this case from 3/4/24 through 3/21/24 I tried to secure lawyer referrals from www.lawyer.com, the agency who referred my previous lawyer, Attorney Arnold Phillips from Honolulu, who died in 2023. I returned to lawyer.com seeking a replacement. My attackers did not want me to succeed again. They also interfered with a phone call I made to lawyer.com. I received a hold notice that played on a continuous loop.
