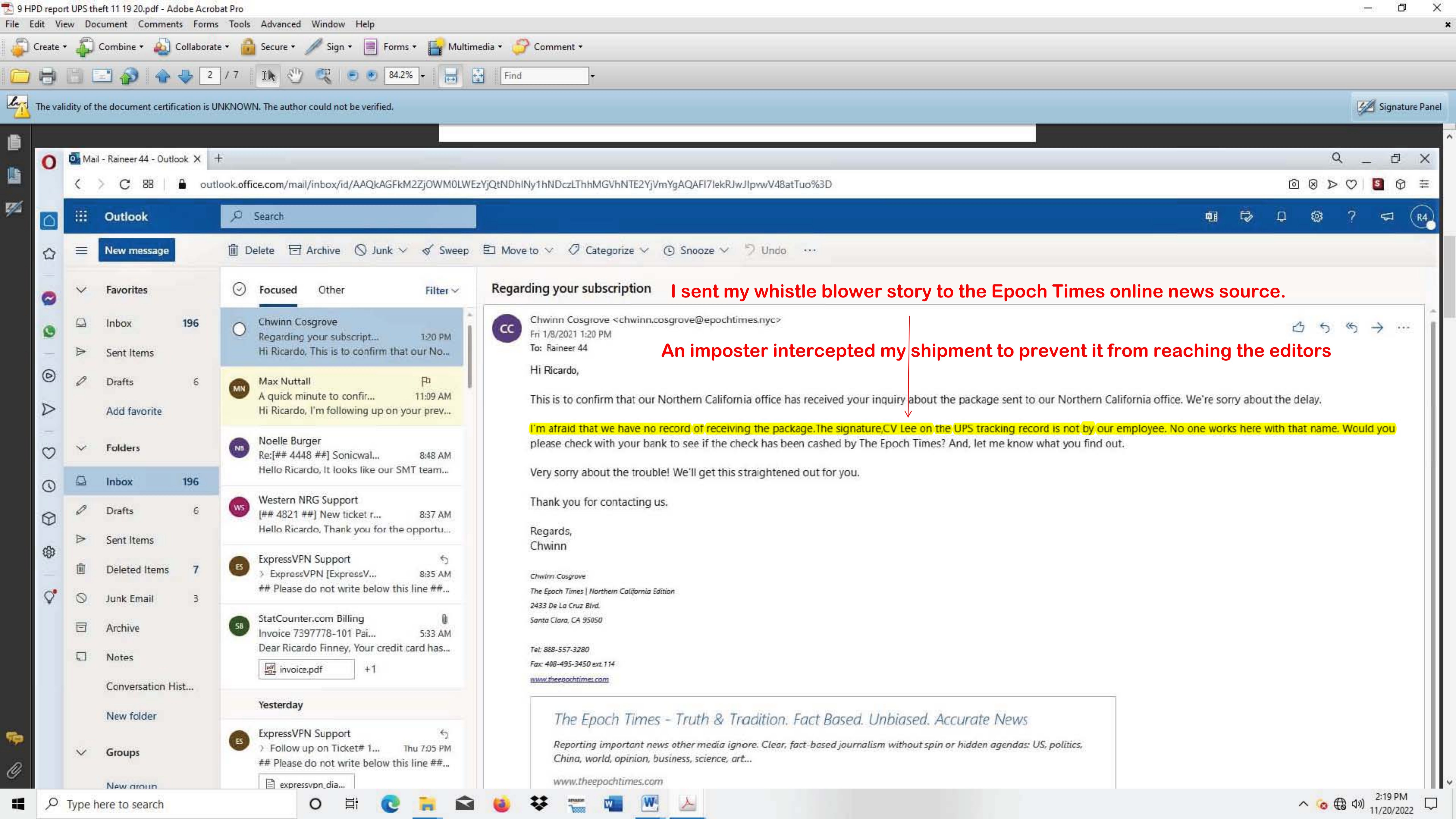

The undersigned freely and voluntarily provides the following statement:

On 11/19/2020 at 1200 pm, a criminal in California intercepted and stole a package containing crime evidence I shipped via 2-Day Express Signature Required to the newspaper publication "The Epoch Times". My package contained a request for a reporter to investigate the crimes I claimed. On 1/8/2021, at 2:00 pm, I learned an imposter signed for then stole my UPS addressed to the Epoch Times newspaper to prevent my evidence from being revealed. I attached written proof UPS delivered my package and secured a signature. I attached written proof the signature is not from someone at the Epoch Times. My package included crime evidence documents and a DVD. The imposter did not want my evidence to reach the Epoch Times. My package also included a \$39.00 check drawn from the Bank of Hawaii intended to pay for a subscription to the Epoch Times. The imposter knows my banking information imprinted in the check. I have cancelled my Bank of Hawaii checking account, but have not yet determined if I have more financial loss as a result of the theft. After I learned my package had been stolen, I submitted a tracer request with UPS through the same storefront I sent the missing package. UPS will reply in 4 days/by January 16, 2021. I contacted UPS personally and requested a property theft investigation. I am a whistleblower. My evidence package shipped from Hawaii to California was intercepted in an attempt to stop damaging criminal evidence from being reported by the press. My bank and UPS recommended filing a police report about the theft and why it happened. Please investigate this crime. I did not give anyone permission to take my package intended for the Epoch Times newspaper. I wish to prosecute.

I attest that this statement is true and correct to the best of my knowledge, and that I gave this statement freely and voluntarily without coercion or promise of reward.
