

On 5/30/24 a series of emails I attempted to send to various media outlets and government oversight agencies with queries asking for crime assistance intervention were repeatedly blocked by cyber criminals to prevent receipt. I received verification the emails were delivered. I sent emails to local addresses that can be quickly verified. All arrived problem-free

Other than hacking, there is no reason my Mainland emails should not be read and answered. They, along with more than 300 emails, fax transmissions, phone calls, USPS Registered and Certified Mail, UPS, DHL International and FedEx parcels have been intercepted and blocked by cyber criminals known by law enforcement and others in positions of authority.

Cyber criminals known by law enforcement have blocked over 300 emails, texts fax transmissions, and phone calls I've attempted to send seeking legal, media, and whistleblower advocate assistance. These emails are part of the group blocked.

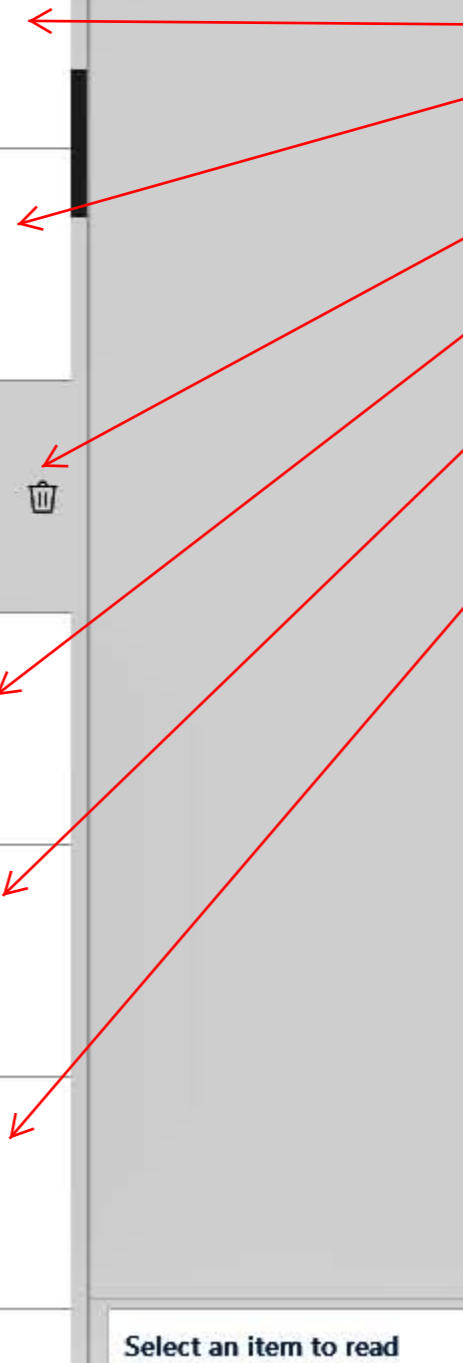
