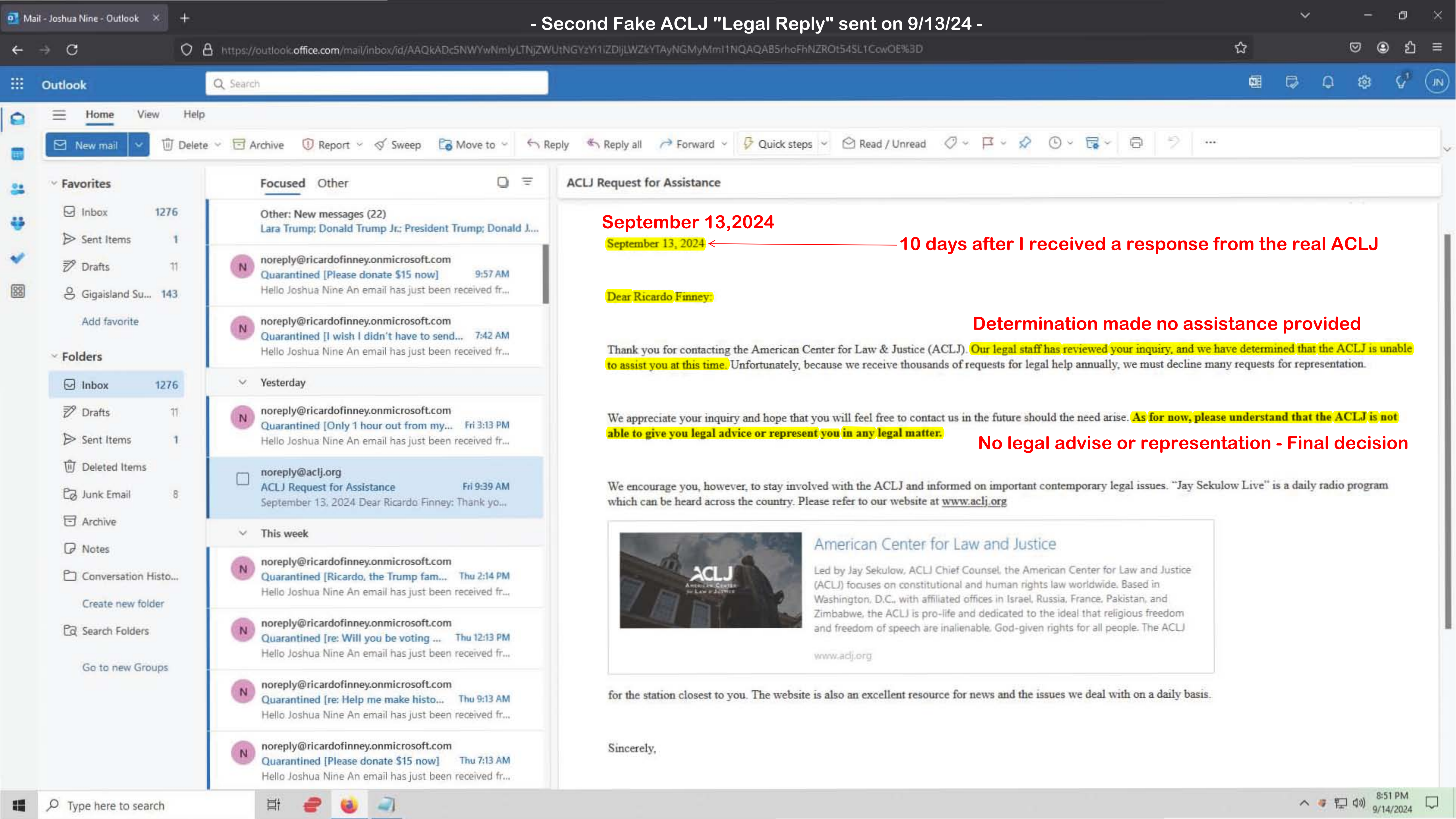

- Cyber Criminals Send Fake Law Firm EMails -

Using my joshuaInine@lionofjudah808.live Outlook address, on 9/5/24 at 7:05 a.m. Hawaii Standard Time I submitted an extensive request for legal help to the American Center for Law and Justice (ACLJ) through their website intake portal. I referred specifics detailing my various crime evidence website, links, and other related data.

At 11:58 a.m. on 9/5/24, I received a email response purportedly from ACLJ Attorney Nathan Moelker. The email included an address from a no-reply? address (known to be used for scam attempts), noted a reference to a courtesy copy to Attorney Benjamin Sisney attached (which didn't exist), requested I give information already provided in great detail in my website submission, included a "smiley face" in an unrecognizable email address line, and failed to provide any contact information that could be verified.

Their ploy can be further verified by asking Attorney Moelker if he sent the 9/5/24 email, or not. Anyone asking will learn he did not.

On 9/13/24 I received a second email purportedly from the ACLU stating (quote) "Our legal staff has reviewed your inquiry, and we have determined that the ACLJ is unable to assist you at this time".

Again, both emails are frauds, generated by the cyber criminals.

- Proof -

On 9/2/24, I traveled across-island, hip-hopping to a location unknown by the cyber criminals, and used an unknown email address (corecore@onmail.com) and computer to contact the ACLJ again through their website. After breaking the cabal's 24/7 illegal surveillance and cyber attacks, on 9/3/24 I received an authentic next-day response from the ACLU. The first fake response from the cyber criminals did not include a request for further information. The second email conveyed an immediate denial.

The true reply from the ACLJ indicated all requests are reviewed before making a support determination. There is no (repeat) no request for additional information. A review is promised. There is no (repeat) no immediate denial. And unlike the fake emails my attackers sent, the real ACLJ notification gives a three-week window for a reply, or not.

Fraudulent emails from the cyber criminals arrived in my Outlook mailbox two (on 9/5/24) and ten days (on 9/13/24) AFTER the authentic ACLJ reply came to me. (9/3/24).

I received these fake emails in response to my submission through the ACLJ website using my compromised network. I received an authentic ACLJ reply after I contacted them through their website using a different network on 9/2/24.

The two emails containing the falsified copy/paste ACLJ content is one of dozens of similar emails I've received from the cyber criminals ultimately found to be malicious. At my evidence link, <https://bit.ly/7yearsofdeceit>, please read details about Mr. Noy from Canada, his \$3600.00 encrypted cellphones I purchased, the cyber criminals actions to hack disable them prevent my use, their impersonated/fake DHL and other emails, and law enforcement's deceitful, malicious, but unsuccessful attempts to get the phones from me for the opportunity to erase the crime evidence they contain.

The cyber attack involving Mr. Noy and his security hardware is among a litany of deceitful personnel and agency impersonations that have occurred from 2016 to the present day, all with zero law enforcement intervention to facilitate the cover ups.

The cyber criminals read all my in and outbound email and Internet traffic, and selectively block or manipulate the content they don't see or responded to. To date they have intercepted nearly 400 emails, texts, fax transmissions, phone calls, phone messages, and website postings I've attempted to send or receive.

By their own demonic hand, their malicious presence and unauthorized intrusion into my network and computers is verified in this documentation beyond any reasonable doubt. My long-standing claims of illegal on and offline surveillance and email intrusion and manipulation is validated.

The email included an address from a no-reply? address known to be used for scam attempts, noted a nonexistent courtesy copy to Attorney Benjamin Sisney, requested I give information already provided in great detail, included a "smiley face" in an unrecognizable email address line, and failed to provide contact information that could be verified.

The email containing the unusual, suspicious content is one of dozens of similar emails I've received from the cabal that was ultimately found to be malicious.

The email included an address from a no-reply? address known to be used for scam attempts, noted a nonexistent courtesy copy to Attorney Benjamin Sisney, requested I give information already provided in great detail, included a "smiley face" in an unrecognizable email address line, and failed to provide contact information that could be verified.

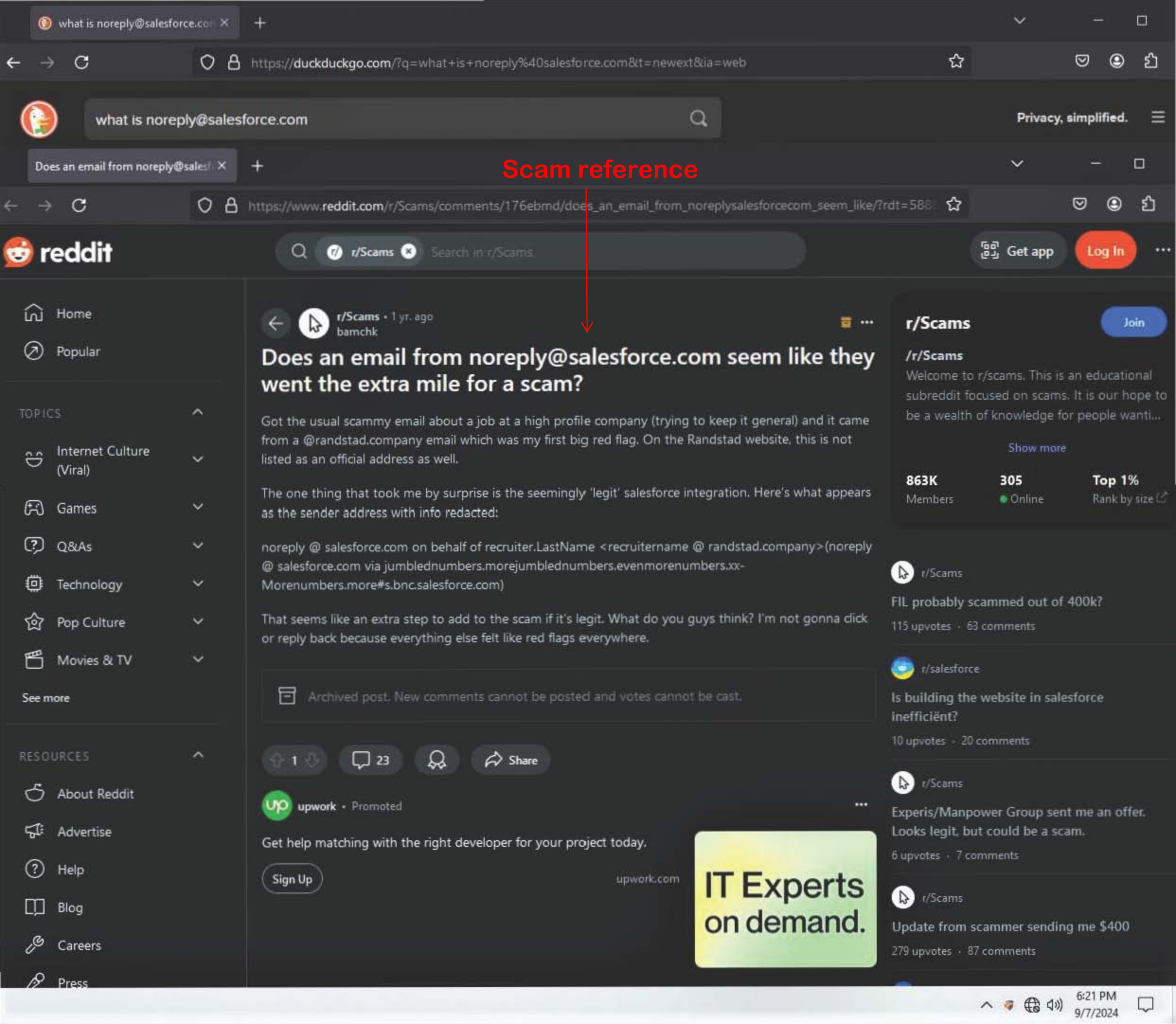

Scam reference

Does an email from noreply@salesforce.com seem like they went the extra mile for a scam?

Got the usual scammy email about a job at a high profile company (trying to keep it general) and it came from a @randstad.company email which was my first big red flag. On the Randstad website, this is not listed as an official address as well.

The one thing that took me by surprise is the seemingly 'legit' salesforce integration. Here's what appears as the sender address with info redacted:

noreply @ salesforce.com on behalf of recruiter.LastName <recruitername @ randstad.company> (noreply @ salesforce.com via jumblednumbers.morejumblednumbers.evenmorenumbers.xx-Morenumbers.more#s.bnc.salesforce.com)

That seems like an extra step to add to the scam if it's legit. What do you guys think? I'm not gonna click or reply back because everything else felt like red flags everywhere.
