

- My Denied Intervention Requests to the Mayor of Honolulu 2023 2024 -

On 9/17/24 with sophisticated cyber attacks, on and offline stalking, and related crimes continuing, I contacted Honolulu Mayor Blangiardi with a 2nd request for intervention after his corrupt police officers facilitated cyber attacks against me while colluding with the FBI to keep all silent and hidden. My new evidence revealed additional cyber crimes I suffered, including being blocked from communicating with attorneys, shadow banning my X and TruthSocial accounts, and an extortion attempt using stolen identities. In 2023 I detailed a litany of other cyber attacks to the Mayor along with a request for intervention. Expecting an answer, I was ghosted.

This time, a year (and hundreds of cyber attacks later) I contacted the Mayor a 2nd time seeking to learn if he would intervene in the midst of the corruption, or continue as a part of it.

His reply left no question:

"Our office stands by the response below that was emailed to you on June 23, 2023"

"...please continue to work with HPD..."

As I told the Mayor on May 30, 2023, directing me back to the agency that harmed me only offers me more of the victimization I've already received. This simple premise and fact is a major cog in the multi-agency, international wheel of deceit, lies, and acts of omission.

The police chief, selected officers under him, and their agents have been, and continue to be among most my most direct persecutors. Irrefutable facts exposing their lies, acts of omission, intimidating tactics, misleading language, purposeful procrastination, evasiveness, and collusion are well documented in great detail. Helping me before, and certainly now is self-defeating and would lead to incrimination. All part of the domestic and international cover up.

Aloha, Mayor Blangiardi

Since my last correspondence to you of which I did not receive a reply, I have, and continue to receive sophisticated, unchecked cyber attacks against my business network, computers, cellphones, and other electronic devices. Illegal, unauthorized surveillance of me in and out of my home continue. These past and present criminal acts are a direct result of the purposeful, conspired, and intentional failure of corrupt Honolulu police officers to investigate and stop a variety of cyber crime and other criminal acts against my family and I from 2016 through 2023, then who deceitfully closed all my cases to keep their malfeasance hidden. Since then, and through the submission of this email, cyber attacks continue.

Documented evidence proving my claims and proof of related cyber crime and other illegal incidents are detailed in my evidence websites, links, audio recordings, and videos.

In 2024:

- In an attempt to keep my victimization silent and hidden, cyber criminals known by HPD and others block me from communicating with lawyers. Cyber attacks prevent me from securing legal representation. Cyber criminals block emails I've sent to and received from www.lawyer.com. Cyber criminals known by HPD and others block my attempt to communicate with the American Center for Law & Justice (ACLJ). The ACLJ will validate they has not received replies from me from email address joshua1nine@lionofjudah808.live.
- Cyber criminals known by HPD and others have blocked my attempts to communicate with the US House Committee for Accountability and Oversight five (5) times. They have blocked my attempts to communicate with the Republican National Committee five (5) times. My claim can be proven by contacting the Committee which will validate they have not received my submissions.
- Cyber criminals known by HPD and others infiltrate my business network around the clock and compromise the work I pay network and computer engineers to accomplish.
- Cyber criminals known by HPD and others modified my firewall security certificate and removed its protection within my network to allow malicious redirects. As an example, my pirated security certificate appears as valid to authenticate secure logins to Amazon. My security certificate cannot validate secure connections to giant Amazon which has its own security certificate.

- Cyber criminals known by HPD and others shadow ban/block me from communicating and interacting on X and TruthSocial. They accessed my iMac computer and disabled the video camera to prevent me from using social media visually. These acts prevent me from publicly exposing crimes and interacting with agencies that will help me end the illegal acts and restore my denied civil rights. The criminals access my devices through my Spectrum business network.

- Cyber criminals immediately erase crime evidence uploads I attempt to post on YouTube, Quora, and Reddit. This is done to prevent me from publicly exposing what has, and continues to happen. They illegally access my computer devices through my Hawaiian Telecom entertainment account.

- Cyber criminals known by HPD and others continue to illegally access my cell phones and those of my family acting to block or disable them while listening, viewing, and interfering with my activities.

- The identity of radio host Dennis Prager was stolen by cyber criminals known by HPD and others and used in an online financial extortion attempts against me. Cyber criminals modified my SonicWall firewall security certificate and removed its protection within my network to allow malicious redirects. As an example, they redirect my attempts to log into my paid subscription at the secure website <https://www.pragertopia.com> owned by radio host Dennis Prager. The criminals route me from his secure/https site to their pirated unsecured/http clone site. This criminal act is done to prevent me from communicating with Mr. Prager.

- In addition to Mr. Prager, the identity of President Trump's attorney Alina Habba was stolen and used in an online financial extortion attempt against me.

- Cyber criminals known by HPD and others continue to intercept and block emails, texts, faxes, and calls I attempt to deliver to media, advocates, and others. They continue to block or disable calls while listening and viewing my activities. I have made over 350 attempts to reach various addresses with zero responses. These include repeated email and fax attempts to reach Senator Jim Jordan at the US House Oversight Committee. The criminal action was done in an attempt to keep what has happened to me silent and hidden from accountability. Persons or agencies from my list of contacts will validate per time and date that they either did not receive my attempt or could not reach me personally through my illegally wiretapped cellphone.

- To keep their violations of my 1st and 4th Amendment civil rights silent and hidden, cyber criminals known by HPD continue to block my online and phone attempts to secure legal representation. Cyber criminals block my attempts to secure legal assistance from civil rights attorney Leo Terrell through his website <https://www.leoterrell.com>. This is done to prevent me from exposing crimes. My claim can be proven by contacting Attorney Terrell who will validate he has not received any online communication from me.

- Cyber criminals known by HPD and others me stalk me when I go to T-Mobile, Verizon, or any other phone store. When I attempt to configure my iPad with cellular service for use, a cyber attack locates my iPad (they know its IMEI number), connects to the phone store's WiFi network, erases the passcode I chose, then installs a random set of digits I cannot determine. Their action immediately locks me out of the device.

- I am also stalked when I attempt to establish or renew prepaid phone service for cellphones. Similar to my iPad, in each store my devices are located via their known IMEI number, then illegally accessed and compromised to facilitate audio and video surveillance.

- Cyber criminals known by HPD and others stalk me online and block my attempts to secure

cellphone service from Visible operated by Verizon. Cyber criminals repeatedly intercept and block the verification email sent to my assigned address. **This is done to prevent me from completing the new account signup process.**

- **I am also stalked at all Apple Stores in Honolulu** where my computers are found via their MAC Address and compromised through the store's secure but breached public Wi-Fi network, then infected or completely disabled.

My right to free speech and right to privacy continue to be violated by the constant cyber attacks and intrusions that HPD and others allowed to occur before, and continue now. All of my desktop and laptop computers, tablets, and cellphones are compromised to different degrees. My personal and professional losses continue to increase as a direct result of the corrupt cadre that are criminally involved.

To summarize in 2024, cyber criminals:

- prevent me from communicating with lawyers
- block my attempts to report my circumstances to the US House Committee for Accountability and Oversight
- continue to breach my networks, compromise my devices, and interfere with technical support I attempt to secure
- attacked, modified, and invalidated my firewall security certificate
- hide my social media presence on X and TruthSocial, blocking me from posting on social media platforms and interacting with users
- erase cyber crime and other criminal evidence
- illegally accessed my cell phones and tablets to compromise or erase them
- block my email, phone calls, texts, messages, faxes
- victimized me through financial extortion attempts
- stalk me online and block my attempts to secure cellphone service
- stalk me when I go to phone vendors, Apple Stores, and block my devices

These crimes continue attempting to keep me silent and all that has happened hidden and unknown. **Blocking my access to the American Center for Law & Justice and others who can provide me legal representation is especially egregious and unlawful.**

I have the constitutional right to be heard without government interference. I have the constitutional right to privacy and not be placed under illegal government surveillance. I have a right to secure legal representation without being silenced by an electronic embargo as if I lived in communist China or in North Korea.

Rightfully, action must be taken immediately and without further delay to stop this litany of cyber attacks and other crimes committed against me. **As I thoroughly documented, your law enforcement personnel I previously interacted with are dishonest and corrupt.** Their intention is to destroy my family and I. **I request you advise what action you as Mayor are going to do to stop the ongoing crimes committed against me.**

I request to not be ghosted again. Please provide your answer by close of business Thursday, September 19, 2024.

Ignored

Aloha, Mayor Blangiardi...

Thank you for your timely reply. Thank you for not ignoring me as others have done. Based on your limited reply and referral back to HPD in response to the detailed information I offered apparently HPD's reply outweighs the request I made for your intervention. I understand the HPD spokesperson told you they referred me to the FBI since they were unable to conduct forensic analysis of my devices because I did not surrender them. Unfortunately whomever you spoke to was not forthright and truthful. I experienced similar acts of omission and false claims many times during my interaction with HPD/CID. The reply you received was carefully crafted to appear as if I was not compliant, I was at fault, and after all this occurred I was referred to the FBI. All that HPD states is false. As I detailed in my first email, HPD/CID devised a scheme to permanently void all the cyber crime cases I filed from 2016 through 2022 to avoid referring any to the FBI and closing their books on my cases without a single thorough investigation.

This truth is proven in entries at my cyber crime evidence site I noted previously:

Entries posted in my site provide evidence that proves what I convey to you is factual and what HPD states is not. I attached four .pdf files that disprove HPD's deceitful reply to you. Other lies and acts of omission intended to stay hidden are revealed.

Referral to the FBI

The last HPD officer I interacted with, Det. Thomas linuma, did **not** refer me to the FBI at the conclusion of our involvement as was claimed. He cannot produce proof to validate his claim that match the timeline. Truth be told, long before he permanently closed my cyber crime cases Det. linuma at HPD tried to coerce me into contacting the FBI on my own instead of referring my litany of cyber crime cases to the federal agency formally as an agency-to-agency support request. At that time I reminded Det. linuma of what he already knew; there is a vast difference in FBI responsiveness to an investigation request from a civilian as opposed to a formal interagency /HPD-to-FBI support request. The attachment titled "Page 83" shows my notice. Det. linuma remained silent and never commented until he notified me he closed my cases with no mention of the FBI. During our 13-week interaction I asked Det. linuma **six** times to refer my criminal cases to the FBI because of their volume, length, age, and complexity. Six times he refused to answer me.

Again, Det. linuma knew all along his direct law enforcement agency input to the FBI generated a higher level of obligation and timely responsiveness than I would as a civilian (which at the time I told him this verbatim). Yet he ignored me.

What the HPD spokesperson also did not explain was the negative interaction Det. linuma planned with the FBI about my cases two months after he permanently closed them. He blocked me, the victim, from involvement. Details are at <https://bit.ly/3LEINLX> go to "4 HPD Closed Ongoing Investigation".

Devices Not Surrendered

The HPD spokesperson claimed I did not surrender my devices. He/she failed to divulge Det. linuma was **unavailable on the day and time he set to deliver my device.** The spokesperson kept hidden that Det. linuma gave me notice on a

Friday to deliver my one/only operable computer partially disabled after multiple cyber attacks the next Monday which would leave me with no computer. **Det. linuma ignored my email input stating I needed more time to have a new computer configured for security.** I reminded Det. linuma of the emails and showed him what I sent that explained the latitude I needed because of the constant cyber attacks. Please read the attachment titled **"Limitations Ignored"**.

I should have been allowed sufficient time to bring a replacement device online securely. Det. linuma choosing to ignore the limitations imposed on me does not make me non-compliant. Det. linuma acted as if I had said nothing. From the beginning of our interaction I informed Det. linuma over and over again about my forced limitations. I attached one example titled **"Advance Notice"** I sent to Det. linuma three weeks **before** he closed my cases.

Considering the fact HPD left every one of my cyber crime cases unattended for nearly 7 years, and Det. linuma did not perform any thorough case investigations while directly involved with me for 13 weeks, there was absolutely no reason for the rush he imposed other than to hurry to close my cases as fast as possible intending to hide the corruption that occurred. For other devices not surrendered, Det. linuma had no grounds to demand a pair of hacked encrypted cellphones I purchased from a Canadian vendor. In his own writing he admitted he had no international jurisdiction, he had no investigative authority, a fact known when he claimed I was uncooperative.

Again, I respectfully ask that you intervene. Directing me back to the agency that harmed me only offers me more of the victimization I've already received. Everything I've explained here HPD knew when they gave you their misleading reply. Considering the effort and amount of time my attackers have invested in retribution and causing damage, without question all who are concerned in law enforcement are read in on this as well as my attackers who read all my email traffic.

As I explained in my first email, none of my cases were thoroughly investigated. Most were completely ignored. As an example, I attached one of the few cyber crime cases I filed that had a "thorough investigation". The attached file titled "Facebook" shows the investigation results from one case involving the takedown of my Facebook cyber crime evidence site and my response to the findings and conclusions. No action was taken after I identified the flawed reasoning given for my site disappearing along with the evidence I posted. My site remains hidden awaiting law enforcement coordination to remove the malicious redirection HPD identified but refused to act to correct.

The negative events I've explained are a minimal amount of what I've been subjected to as a direct result of HPD's negligence. I only address the end of our interaction as HPD referenced. Whoever responded to you knew what I have exposed occurred when they gave you their misleading reply. Directing me alone back to the agency that harmed me only offers me more of the victimization I've already received. I continue to receive cyber attacks. My need for relief is more dire and more urgent than I expressed in my prior correspondence.

Each day that passes with proper law enforcement action results in money and time lost for me. I cannot buy, sell, or trade online without interference. I am attacked and blocked when I attempt posting on social media. Again, I respectfully ask that you intervene. I ask for accountability for what I've exposed to you. Please task your police chief to have the 10 actions listed in my previous email accomplished and have the previous restrictions imposed by Det. linuma removed. I respectfully request a timely response as before. Thank you for your valuable time. I await your reply.
